Board Outreach Calendar:

Northern Lights - Carrie and Alice presented a two-hour speaker meeting with the topic of hope on March 19th.

Finances:

10% over budget approval: Carrie reported that there was no over budget approval needed at this time.

Region One Assembly 2022: Assembly will take place virtually on October 15-16, 2022.

Alice will help Lesley update the registration application so we can get it out in May.

Alice reported that the Assembly Notebook committee is considering having just the first ten

sections be part of the printed version and the last six sections available only online. The committee is also considering transitioning the Notebook to only online.

PIPO Lake Country: The grant to Lake County that was approved via email was ratified.

Carrie made a motion that the \$550 PIPO grant be approved. Beverly seconded the motion. It carried unanimously.

Region One Convention 2022: Convention will take place November 11-13, 2022. Laurie and Sue shared about the work progressing on Convention 2022. The theme will be 'The Joy is in the Journey'. There will be a planning meeting the last Sunday of each month at 6pm Pacific time. There was a good turnout for the first meeting March 27, but more volunteers are needed. The next planning meeting is April 24th at 6pm Pacific time.

Addition to WS Policy Article VIII; Section 3–Delegates: Margie brought to our attention a proposed amendment to Bylaw Amendment Proposal 4. The proposed amendment to the Amendment Proposal would add interpreters for individual delegates with medically confirmed speech or hearing disabilities to the list of non-delegates who may address the World Service Business Conference.
